23 A. Updates from Other Boards

24 • Planning Office - Planning Staff

25 Ms. Owens updated the Committee briefly on ongoing projects including those in the  
26 Mt. Support Road area.

28 • Safe Routes to School - Planning Staff/Police Staff

37 • Police Reports - Alan Schnur  
38 Mr. Schnur presented the "2006-2019 Lebanon NH Pedestrian and Bicyclist crash

1 data (updated February 3, 2020)". The aim of the update is to collect and analyze  
2 ped-bike crashes, including those with motor vehicles, to look for patterns, measure  
3 trends, and look for potential causes in order to take action and recommend  
4 interventions that may prevent future crashes. The total number of crashes involving  
5 ped-bike users was about 50 percent lower 2006-2014 than it has been trending  
6 2015-2019, however it was noted that the population of Lebanon has not changed  
7 much between 2006-2019. The presentation will be posted on the committee's  
8 webpage and Ms. Owens will request the Police Department to provide the full 2018-  
9 2019 data details for more comprehensive review.

- 11 • Mascoma River Greenway Coalition - Colin Smith  
12 The MRG working group is supportive of doing a survey in June or July, preferably via  
13 in-person interviews on the trail. To encourage participation and with volunteer  
14 comfort approaching trail users, sandwich board signs could be situated near the  
15 survey distribution points. It was suggested to do the survey during at least two  
16 different windows of time. Mr. Schnur volunteered to help. Some survey goals were  
17 identified such as: to build user data that may support communications with the State  
18 of NH to permit right-of-way use for rail-with-trail or similar and extend the greenway,  
19 to get a sense of user perceptions on trail safety including as relates to cyclist speeds,  
20 usership types and frequency, and feedback about the trail's accessibility. A digital  
21 traffic counter could be deployed but they have limitations.

  - 23 • State of NH Updates  
24 Mr. Belenz reported that the New Hampshire Department of Transportation's  
25 (NHDOT) Ten-Year Plan Update has completed review by the Governor and public  
26 input and is now in the legislature, but there is usually not a lot of change at this point.  
27 Projects include the Slayton Hill rotary on Route 4, and the plan should be done by  
28 June. Mr. Belenz also reported that the process for the state's Ped-Bike Plan has  
29 been extended and that a new state rail-trail plan is coming together to help balance  
30 user needs, including ATVs, for which some committee member concern was  
31 expressed.

  - 33 • Rails to Trails-VACANT  
34 Ms. Owens will attend a February 19<sup>th</sup> meeting hosted by the Rails to Trails  
35 Conservancy to consider a regional network in the Northeast.

### 37 5) OTHER BUSINESS:

- 39 A. Speed limits: The committee reviewed a memo that had been shared by email, a  
40 proposal from Lebanon Police Chief Mello to the Mayor and City Council to reduce local  
41 speed limits. The memo presents traffic study data and recommendations for the City to  
42 adopt a lower speed limit, 25mph, for most local streets, especially to support existing  
43 speed conditions and safety priorities. The committee decided to present a motion of  
44 support of the proposal to be shared with City Council prior to their March 4<sup>th</sup> public  
45 hearing to review the proposal.

47 **Mr. Keller MOVED to pass the following MOTION:**

49 ***The Lebanon Pedestrian and Bicyclist Advisory Committee strongly supports the***  
50 ***Lebanon Police Department's recommendation, as written in a memorandum to the***  
51 ***Honorable Mayor and City Council, dated January 23, 2020, "setting the minimum prima***  
52 ***facie speed limit in the City of Lebanon at 25MPH, unless otherwise posted"***.

- 5 B. Road Resurfacing: The committee discussed that road resurfacing projects will be the
- 6 focus of Mr. Smith's next quarterly report to City Council and Ms. Owens will work with
- 7 Planning staff to provide related information for a proposed Public Safety Committee
- 8 review, in advance of seeking City Council feedback as a potential agenda item. A
- 9 response to NHDOT is time-sensitive, to address their 2020-2012 projects. The
- 10 committee discussed that if the Council were to review this issue, it would be good to
- 11 have in-person committee member presence, with different members taking on short
- 12 talking points to each supporting piece for encouraging reallocation of shoulder space
- 13 from travel lane widths *where feasible* during City and NHDOT roadway resurfacing and
- 14 similar projects. Oral testimony, it was discussed, often has greater impact than motions
- 15 and written statements.
- 16 C. Bike Rodeo: Ms. Owens noted that the date has been set for June 6, 2020 and outreach
- 17 needs to be initiated.
- 18 D. Lebanon Bike Racks: Ms. Owens reported that the racks have been received and
- 19 fastening bolts are on their way to enable installation.
- 20 E. Communications Plan: Ms. McCormick presented the latest draft of the plan. For
- 21 February, Ms. Owens was asked to develop a LebNews "Scan the Streets" posting, and
- 22 to work with Mr. Belenz to get a NHDOT public service announcement incorporated in
- 23 the posting. Ms. McCormick would then request local leader(s) to talk about related
- 24 messaging on local radio shows. It was clarified that the plan is not just a menu, that it
- 25 shows actions that the community has already indicated are priorities, and the plan will
- 26 be reviewed at each meeting. Responsibilities for outreach to "potential collaborators"
- 27 was discussed, including for Mr. Smith to invite the Lebanon Middle School principal to
- 28 the March meeting, Ms. Owens to ask SAU88 about their current efforts, and others to
- 29 eventually contact Hypertherm, CHaD, the Masonic Temple, and beyond, ideally
- 30 creating a contacts list or spreadsheet to facilitate future communications about events,
- 31 volunteer needs and partnerships.

- 45 4. Marie McCormick (MM) to write an introductory paragraph for distribution of the Draft
- 46 Communications calendar and send to RO.
- 47 5. RO to distribute Draft Communications calendar to PBAC members for comments.
- 48 6. PBAC members to review Draft Communications calendar and provide comments,
- 49 including further details of activities proposed.
- 50 7. Communications WG (MM, JK, AS) to develop and share with CS and RO the template
- 51 to be used when contacting partners.

- 3 9. RO to check on what is the ped-bike related safety education currently being provided in
- 4 Lebanon schools.
- 5 10. John Kelleher (JK) to discuss with LHS principal Ian Smith what ped-bike related safety
- 6 education is currently being provided at LHS.
- 7 11. CS to discuss with LMS principal what ped-bike related safety education is currently
- 8 being provided at LMS.
- 9 12. RO to finalize and distribute PBAC motion endorsing LPD and Public Safety Committee
- 10 recommendation on reducing the local speed limit to 25 mph on Lebanon streets.
- 11 13. RO to inform PBAC of the date when speed limit reduction recommendation will be
- 12 discussed by the City Council.
- 13 14. All PBAC members to consider attending City Council meetings when ped-bike issues
- 14 are on the agenda to support positions and lend their voices to the discussions.
